

About Us

Neighbourhood Watch Australasia (NHWA) is the peak body of Neighbourhood Watch in Australia and Neighbourhood Support New Zealand.

NHWA supports and works to enhance the safety and security of communities through the sharing of ideas, information, and resources, and through the development and delivery of community programs that encourage participation in crime prevention for building safe, confident, and resilient communities.

NHWA works to empower communities to prevent crime at a grassroots level through education, initiatives and programs developed and delivered through partnerships with local, state, federal, and international entities and experts. In 2003 the Neighbourhood Watch Australasia torch was lit in response to the need for a 'National Secretariat as a collaborative body that assists with the sharing of information between the various programs on issues such as information technology, facilitating national sponsorship and uniform marketing strategies.'

By 2006, at the Neighbourhood Watch Conference held in Adelaide, delegates representing all Australian states, territories, and New Zealand, voted to adopt a draft constitution in agreement that Neighbourhood Watch Australasia would become an Incorporated Association 'as a central information gathering and dissemination point' for Neighbourhood Watch and Neighbourhood Support groups across the Australasian region. In the two decades since, Neighbourhood Watch Australasia has carried the torch forward, growing from an incorporated association to a company limited by guarantee and a registered charity, regulated by the Australian Charities and Not-forprofits Commission (ACNC).

In 2023 NHWA serves the community in a way that in 2003 was only just beginning to be envisioned as being the future potential of a peak Australasian Neighbourhood Watch body.

The emerging vision was 'to use the existing Neighbourhood Watch structure as a vehicle to further build partnerships with police and the community, increase the quality and quantity of police citizen contact (and thus legitimacy) and at the same time build community capacity [and] help to strengthen communities and lead to benefits that will only be apparent in the longer term.'

In 2023 NHWA proudly delivers on this potential as the peak body for Neighbourhood Watch in Australia and Neighbourhood Support New Zealand as a matter of course for business as usual, while continuing to adapt to meet and respond to the ever-evolving needs of ensuring community safety and security.



Safer Australia For Everyone (SAFE) program

The Safer Australia For Everyone (SAFE) program, led by Neighbourhood Watch Australasia (NHWA) in collaboration with The University of Queensland (UQ), aims to enhance home safety and security across Australia. Implemented in response to a rise in break-and-enter incidents, the SAFE program is a federal government funded initiative consisting of three tiers, aimed at empowering householders to bolster their home security.

In the 2022-2023 financial year, NHWA concentrated on advancing the SAFE program, building upon the foundation laid in the previous year. The program's primary objective is to reduce break-ins by promoting home security awareness and encouraging participation in its initiatives. Driven by the principles of Crime Prevention Through Environmental Design (CPTED), the program incorporates strategies like target hardening and cocooning to enhance security in built environments.

NHWA has partnered with Dr. Renee Zahnow, Senior Research Fellow, School of Social Science, Criminology, The University of Queensland, to develop and distribute SAFE program CPTED strategies and resources within the community. Dr. Zahnow is also conducting post-evaluation and reporting on the SAFE program, which will be used to inform and direct future home and community safety initiatives.

Dr Renee Zahnow said, "As we all return to normal daily activities post COVID-19, it is vital that we encourage the community to review their home security. The Safer Australia For Everyone (SAFE) program provides strategies to empower individuals to take steps towards reducing their risk of victimisation and reducing crime in their community."

NHWA envisions a Safer Australia For Everyone, where every citizen feels secure in their home. By raising awareness, providing resources, and engaging communities, the SAFE program strives to curtail breakins and enhance overall security nationwide. Through collaborative efforts and the integration of CPTED principles, the program aspires to create lasting positive impacts on home security and feelings of safety.

CPTED Training

Neighbourhood Watch (NHW) volunteers and local community members in Canberra (ACT), Toowoomba (QLD), and Belmont (WA) are receiving training in Crime Prevention Through Environmental Design (CPTED) practices. The CPTED program involves guidance on target hardening for both homes and communities, as well as cocooning. The partnership with UO ensures the evidence-based development of home security assessment checklists, resources, and surveys, gathering valuable data for future security initiatives.

Target Hardening Program

Scheduled for launch in July 2023, NHWA's Target Hardening Program will enhance security in eligible homes. Up to 500 homes in the three selected locations will be offered improvements valued at up to \$500, encompassing measures like locks, sensor lights, security screens, and CCTV cameras. The program empowers homeowners who have been a victim of crime to take proactive steps to improve home security.

National Secure Your Home Day

NHWA's inaugural National Secure Your Home Day, set for 23-24 September 2023, encourages Australians to assess and enhance their home security. Participants receive a free National Secure Your Home Day Kit, featuring a downloadable Home Security Checklist, created in collaboration with UQ, and advice on proactive home security measures. Registered households can also engage in activities, including a children's colouring competition, and gain insights into local community events. A dedicated website www.secureyourhomeday.com.au serves as a hub for the event.

Campaign to protect children from online sexual exploitation

In April 2023 Neighbourhood Watch Australasia (NHWA) launched the newest in its series of television commercial Community Service Announcements (CSAs), Keeping Kids Safe Online.

Developed in collaboration with the Australian Federal Police (AFP) led Australian Centre to Counter Child Exploitation (ACCCE), NHWA's Keeping Kids Safe Online CSAs inform children, parents, and carers how to recognise, respond to, and report online child sexual exploitation and abuse.

The three CSAs, funded by the Westpac Group 'Safer Children, Safer Communities' Grant, have been produced in direct response to the need for there to be open communication and dialogue about online child sexual exploitation and abuse, and to empower the community to better protect children and young people.


Reports of online child exploitation to the ACCCE have more than doubled across each of the four years of the law enforcement agencies' operation since 2018. Market research commissioned by the ACCCE into online child sexual exploitation in Australia* included the following key findings:

The TV commercial Community Service Announcements (CSAs) have been well-received by the Australian broadcasting sector and are being aired during primetime across Australia on Paramount Network 10, WIN TV, GOOD TV, and on C31 (a Melbourne community television station). Feedback from members of the community who have viewed the CSAs, both in cities and regions, has been resoundingly positive.

NHWA's Keeping Kids Safe Online project has been endorsed by the Hon Mark Ryan MP, Queensland Minister for Police and Corrective Services and Minister for Fire and Emergency Services, who wrote in support of NHWA's application for further funding to produce additional Child Online Safety CSAs: "I have seen firsthand the hard work and dedication that NHWA put into their community, and the vital contribution they make to improving community safety. Funding towards the production of community service announcements would allow the team to continue to educate about how to recognise, respond to and report online sexual exploitation. NHWA's partnership with the ACCCE on this issue is an invaluable community resource."

At the April 2023 ARGOS Queensland Police Service Youth, Technology and Virtual Communities Conference, the Keeping Kids Safe Online CSAs were screened during the ACCCE's Commander Helen Schneider's presentation, "The Power of Partnerships for Success" as an example of effective and valuable entity partnership outcomes.

NHWA is committed to continuing to produce further campaigns and projects to work towards Keeping Kids Safe Online, and recognises that the protection of children does not exist in isolation, but instead requires strong effective partnerships and community collaboration. By working closely with our partners and communities, NHWA aims to educate parents, carers, and children to know what to look out for, how to respond and discuss, and how to report, to protect children and young people against the increasing risk of online child sexual exploitation.

Be Connected Digital Mentor Training

Building digital literacy skills, safety, and connections in communities

In testament to the power of collaborative partnership and initiatives, Neighbourhood Watch Australasia (NHWA) delivered a fourth round of Good Things Foundation's (GTF) Be Connected Capacity Building training during 2022-2023. This round of training resulted in over 100 additional Digital Mentors being certified by NHWA in this year's cohort, ready to go out into their communities to empower otherwise excluded individuals with access to digital skills and pathways. This round of training brings NHWA's tally of trained Digital Mentors to over 400 mentors Australia-wide!

Over the course of delivery of the 2022-2023 Capacity Building program, NHWA held 13 Digital Mentor training sessions with an average of 8 participants per session. The participants included NHW volunteers, retirees, and students, however, the majority of attendees (64%) were aged between 30 and 59 years of age, all looking to volunteer their time to help others improve their digital skills.

An unanticipated outcome of COVID-19 was the rapid integration of local communities accessing national and global communities via digital pathways. NHWA's online Digital Mentoring delivery model, established during the pandemic, continues to fill an evidently ongoing need in the community for convenient, flexible, online

training. NHWA is well positioned to provide training courses to learners nationwide, in their familiar, safe, and accessible environments. NHWA delivers the Digital Mentor programs remotely into local settings, across urban, suburban, diaspora, and regional communities, with the online model being accessible for people and communities who may otherwise be excluded.

The diverse cohort of NHWA's Digital Mentors represent various countries of birth, with over 21 languages spoken. NHWA's Capacity Building model enables individuals to become qualified Digital Mentors, to deliver high-quality digital support services within both their immediate and online communities.


Neighbourhood Watch members across all states have also increased participation in NHWA's Digital Skills program, with these participants often increasing their abilities to enhance the delivery of other digital skill improvement programs, including Get Online Week.





Connecting our communities

In an era where community connection is more important than ever, Neighbourhood Watch Australasia (NHWA) proudly presents NHW Connect - an innovative platform aimed at fostering strong bonds between communities and their local Neighbourhood Watch (AU) and Neighbourhood Support (NZ) groups.

Launched in 2023, NHW Connect is a new way for communities across Australia and New Zealand to connect with their local groups.

The NHW Connect website enables visitors to browse, search and connect with groups – using an interactive map and search function.

The interactive map uses Google Geocoding API to indicate the approximate location where each group operates (using address details supplied, which are converted into latitude and longitude coordinates). Contact details for each group are also shown (as available), making it easier than ever for people to find a local Neighbourhood Watch (NHW) or Neighbourhood Support New Zealand (NSNZ) group to Connect with!

As well as finding nearby existing groups and connecting with group coordinators, visitors can also get in touch with their local jurisdiction's head office about starting a new group.

Safety in Numbers

In March 2023, Neighbourhood Watch Australasia (NHWA) and crime prevention partner Crimsafe came together for another successful Neighbourhood Watch Month campaign, to raise awareness of the benefits of joining a Neighbourhood Watch (NHW) group for both individuals and the wider community, and to educate householders on ways to protect their home.

This year the theme of Neighbourhood Watch Month was 'Safety in Numbers', encouraging householders to connect with others in their community - including NHW groups - to build safer, more crime-resilient neighbourhoods. This is because we are safer together, and by collectively improving the security of each home in their local area the risk of crime is reduced.

Householders were also shown there's 'Safety in Numbers' by improving their Secure Score - the higher a home's Secure Score, the better protected it is against break-ins, theft or property damage. Likewise, the higher the average Secure Score in a local community, the more resilient individual households are against crime.


Throughout the month of March, both Crimsafe and NHWA shared a tiered action plan across their websites and social media, listing home security improvements that a homeowner could make to increase their Secure Score by up to 66 points. While some security improvements are an investment, many required no cost - proof that improving home security doesn't have to be expensive. By boosting their Secure Score, residents improved not only their home security, but also enhanced community safety.

The tiered actioned plan included 'scored points' for preventative actions such as:

+5 points	Moving your wheelie bins to a secure location, and not leaving them against the house for easy access to upper levels or windows
+6 points	Lock your garden shed and garage
+6 points	Install sensor lights around external doors and windows
+4 points	Install visible alarms or CCTV cameras
+8 points	Install security screens on your doors and windows

At its core, the 'Safety in Numbers' campaign is about people and neighbours coming together, to collectively work to create safer neighbourhoods, starting at their own front gate.





Secure September

Clean up crime campaign

Crime prevention partners Neighbourhood Watch Australasia (NHWA) and Crimsafe joined forces once again for Secure September, a month-long national safety behavioural change campaign with a clear and simple message: 'Clean up Crime'!

The annual campaign encourages Australians to become more security conscious and make improvements to enhance their home security, while promoting a community-minded approach to crime prevention and the benefits of involvement with their local Neighbourhood Watch groups.


Now in its second year, Secure September 2022 highlighted the simple yet effective ways in which home security can be improved, and how undertaking security checks can easily be combined with similar spring-cleaning tasks around the home - all with one goal in mind: to improve a home's Secure Score.

From cleaning and checking spotlights, to decluttering the office to prevent identity theft, each day of the month during Secure September offered a simple yet effective home security and springcleaning tip via Crimsafe and NHWA's social media channels. Messaging was also shared via radio ads - through Australian Radio Network (ARN) Media, one of Australia's leading Broadcast and On-demand audio companies with 58 stations nationwide in addition to digital entertainment platform, iHeartRadio, reaching over 6 million listeners - and across both NHWA and Crimsafe's websites.

Individuals were also encouraged to use Secure Score, a free home security audit tool (developed in 2021 by NHWA and Crimsafe) that rates the effectiveness of householders' overall home security, based on current home features and security set up, and to consider joining their local Neighbourhood Watch group. Together we can clean up crime!

Secure Score

Home Security Audit Tool



Secure Score – launched during Secure September 2021 – gives householders a free, accessible way to evaluate their home's security, and practical, cost-effective tips and advice for improving security and making their home and community safer.

Developed by crime prevention partners Neighbourhood Watch Australasia (NHWA) and Crimsafe, the Secure Score home security audit tool is an ongoing initiative that rates the effectiveness of Australian householders' overall home security, based on current home features and security set up.

Households are prompted to answer a series of questions about their current home security measures, which are then analysed to provide a security score rating out of 100.

Based on their answers, householders are provided with a tailored action plan to help improve their Secure Score and the overall security of their home and property.

Insights from Secure Score data have highlighted some simple and effective actions homeowners can take to improve their home security. For example, adding a sensor light, trimming trees and shrubs near windows, and leaving shoes at the front door improves your Secure Score, and your home security.

With 151,200 victims of 'unlawful entry with intent' recorded in Australia in 2022, an increase of 9% (12,112 victims) from 2021, it's more important than ever for householders to be aware, informed, and empowered to keep their homes safe.

The Secure Score tool provides an opportunity for Australian families to take control of their home security and help arm them with the knowledge they need to better protect their homes and neighbourhoods.

Australia's average Secure Score is **56**.

Australian Centre to Counter Child Exploitation

Neighbourhood Watch Australasia (NHWA) has been a proud partner of the Australian Federal Police (AFP) led Australian Centre to Counter Child Exploitation (ACCCE), the ACCCE (pronounced ACE), since the agency's establishment in 2018.

The ACCCE provides a national capability not held by any single federal or state agency in Australia, delivered in response to the increasing number and severity of reports of child exploitation received by Australian law enforcement.

The ACCCE brings together a world-leading approach founded on a principle of partnership, incorporating key stakeholders and partners, and driving a collective effort to counter the epidemic of child exploitation.

NHWA is committed to actively supporting the ACCCE as a key partner through the ACCCE's five pillars to free children from exploitation: Prepare, Prevent, Protect, Pursue and Promote.

During the 2022-2023 year NHWA attended regular stakeholder meetings and roundtables with the ACCCE and other partners, including the International Centre for Missing and Exploited Children (ICMEC AUSTRALIA).

In September 2022 NHWA had the opportunity, along with fellow associate ACCCE partners,

including representatives from the Daniel Morcombe Foundation, yourtown, Bravehearts, NAPCAN, and Act for Kids, to attend an event hosted by Acting Deputy Commissioner Operations Lesa Gale, at which the Attorney-General, the Hon Mark Dreyfuss KC, was invited to sign the new ACCCE vision board, committing to a world where children are free from exploitation.

In early 2023 NHWA partnered with the ACCCE to produce a powerful series of three television commercial Community Service Announcements (CSAs), Keeping Kids Safe Online, to inform children, parents, and carers how to recognise, respond to, and report online child sexual exploitation and abuse. The Keeping Kids Safe Online CSAs have been well-received by the Australian broadcasting sector and are being aired during primetime across Australia on Paramount Network 10, WIN TV, GOOD TV, and on Melbourne's C31.

At the April 2023 ARGOS-Queensland Police Service Youth, Technology and Virtual Communities Conference, the Keeping Kids Safe Online CSAs were screened during ACCCE Commander Helen Schneider's presentation, "The Power of Partnerships for Success".

ThinkUKnow Program

ThinkUKnow was established in 2009 and is Australia's first and only nationallydelivered, law enforcement-led online child safety program, supporting the critical work of the Australian Federal Police's Australian Centre to Counter Child Exploitation (ACCCE).

A collaboration between ThinkUKnow, the ACCCE, the Commonwealth Bank, Microsoft, and Datacom, the program is delivered in partnership with all State and Territory Police and Neighbourhood Watch Australasia (NHWA).

ThinkUKnow is an evidence-based education program and Australian national law enforcement led online child safety program that delivers community presentations and learning resources with a focus on preventing online child sexual exploitation.

The ThinkUKnow program is pro-technology and addresses topics including selfgenerated online child sexual exploitation material, online grooming, image-based abuse, sexual extortion, and importantly encourages assistance-seeking behaviour. The program supports parents, carers, and teachers to get a better understanding of the types of things that children and young people SEE, SAY and DO online.

In-person ThinkUKnow parent, carer and teacher presentations and engagements can be booked through NHWA for any organisation, community group, sporting club or other group, and are available year-round.

In November 2022, the ACCCE and ThinkUKnow held a stakeholder event to introduce a new children's picture book to help kids recognise the signs of online grooming. Written by Tess Rowley and illustrated by Shannon Horsfall, Jack Changes the Game, takes a child's perspective to online grooming, the challenges they face and why it's important to talk to a trusted adult if they encounter any problems online.



Jack Changes the Game is designed to be co-read by parents, carers and educators with children aged 5 to 8. It encourages important conversations about inappropriate contact, online grooming, why it's important to speak up, and where to get help and report.

Facilitating Digital Inclusion 'Try One Thing'

In the ever-evolving landscape of digital technology, ensuring that everyone has access to the opportunities it brings is a pressing concern. Recognising this need, Neighbourhood Watch Australasia (NHWA) was once again a key Network Partner for Good Things Foundation's Get Online Week (GOLW), actively fostering digital inclusion and digital skill improvements through the annual national GOLW initiative.

Get Online Week has been held in Australia since 2018, with NHWA and NHW groups participating every year, contributing well over 100 events to date. In 2022 NHWA facilitated 26 Neighbourhood Watch (NHW) groups to access \$28,600 in GOLW

grants, and to participate in over a total of 1,000 GOLW events nationally, reaching more than an impressive 15,400 individuals.

The theme for this year's Get Online Week was 'Try One Thing', and NHW groups once again rose admirably to the GOLW occasion, holding both in-person and online community events to provide assistance and guidance in how to use digital devices and safely access online services. Increasingly, NHW members are taking up the baton to participate in NHWA's Digital Mentor training programs specifically to be better prepared and equipped to assist and mentor members of the community during Get Online Week.

NHW GOLW events included face-to-face and online events, with a range of morning and afternoon teas, door prizes and fun activities, seminars and conferences, and community engagement activities on offer. Interestingly, there was a noticeable emphasis on cyber safety and how to stay safe online included in the NHW GOLW events delivered during 2022.

The resounding message from the GOLW events is that digital inclusion is not just a matter of convenience, it is imperative for building a more equitable and connected society. Through collaboration, innovation, and a shared vision, we can all continue to bridge the digital divide between those with digital skills and those with no or low digital skills, and empower individuals to seize the countless opportunities that the digital world offers.

As NHWA looks to the future, the organisation remains committed to advancing digital inclusion and empowering individuals to confidently and safely embrace the digital age. Through ongoing efforts, NHWA endeavours to create a more digitally inclusive society, where all individuals can thrive safely in an everevolving virtual world and community.

During NHW Week 2022, NHWA CEO Maria Bennett appeared on Studio 10 to talk about the simple measures we can all adopt to improve our home security, including proven target-hardening techniques and behavioural changes.

In early 2023, NHWA began its powerful campaign to protect children from online sexual exploitation, through a series of Community Services Announcements (CSAs) created in collaboration with the Australian Centre to Counter Child Exploitation (ACCCE). The 'Keeping Kids Safe Online' TV commercials aired across several networks including Network 10, WIN Network, C31 Community Television Melbourne, and GOOD Pay TV. NHWA extends its gratitude to these networks for their generous time and effort in helping promote this important child safety messaging to the public and help protect them from harm.

Neighbourhood Watch Australasia (NHWA) has maintained a strong financial position during the 2022-2023 financial year, with all projects delivered in line with budgeted costs.

2022-2023 is the second year of NHWA's three-year Safer Australia For Everyone (SAFE) program. SAFE is funded by the Commonwealth Government through the Grants to Australian Organisations Program. The SAFE program delivers across three tiers: (i) training to build community capacity and resilience, (ii) target hardening support for victims of crime, and (iii) establishment of a national portal for community to easily access information to improve home security. See pages 26 and 27 for more information.

NHWA was again a successful grant recipient from Good Things Foundation programs, Get Online Week and Digital Capacity Building. These grants have enabled NHWA to assist 26 grassroot Neighbourhood Watch groups to provide digital upskilling in their local communities, and to train over 100 Digital Mentors to assist older Australians with digital technology. In addition, through NHWA's partnership with Crimsafe, two further projects, Secure September and Neighbourhood Watch Month, were delivered during 2022-2023.

The end of COVID-19 as a global health emergency has allowed re-engagement in-person, which has been beneficial to the organisation and the community, however, this resumption is reflected financially in correlating increases in travel and administration expenditure. Employee and marketing costs also increased during 2022-2023, as budgeted for in the delivery of the SAFE projects, however, through careful financial management NHWA achieved a surplus for the 2022/2023 financial year of \$13,023.

Over the past several years NHWA has been consistently consolidating its balance sheet, which is now in a strong position. NHWA will be looking at securing further diversified funding arrangements from various sources over the next twelve months and beyond.

The Board's appreciation is extended to the CEO, Maria Bennett, for her tireless efforts to ensure that the organisation is financially strong. To the CEO and all members of staff, our thanks for the outstanding contributions you have made to NHWA during the last financial year.

To our many supporters, thank you for your considerable interest in the work being undertaken by the organisation and we look forward to this continuing.





Notes to the Financial Statements

Neighbourhood Watch Australasia Limited

FOR THE YEAR ENDED 30 JUNE 2023

1. Statement of Significant Accounting Policies

The directors have prepared the financial statements on the basis that Neighbourhood Watch Australasia Limited is a non-reporting entity because there are no users dependent on general purpose financial statements. These financial statements are therefore special purpose financial statements that have been prepared in order to meet the requirements of the Australian Charities and Not-for-profits Commission Act 2012. Neighbourhood Watch Australasia Limited is a not-for-profit entity for financial reporting purposes under Australian Accounting Standards.

The financial statements have been prepared in accordance with the mandatory Australian Accounting Standards applicable to entities reporting under the Australian Charities and Not-for-profits Commission Act 2012 and the significant accounting policies disclosed below, which the directors have determined are appropriate to meet the needs of members. Such accounting policies are consistent with those of previous periods unless stated otherwise.

The accounting policies that have been adopted in the preparation of the statements are as follows:

Trade and Other Receivables

Trade receivables and other receivables, including distributions receivable, are recognised at the nominal transaction value without taking into account the time value of money. If required a provision for doubtful debt has been created.

Investments held are originally recognised at cost, which includes transaction costs. They are subsequently measured at fair value which is equivalent to their market bid price at the end of the reporting period. Movements in fair value are recognised through an equity reserve.

Trade and Other Payables

Trade and other payables represent the liabilities for goods and services received by the company that remain unpaid at 30 June 2023. Trade payables are recognised at their transaction price. They are subject to normal credit terms and do not bear interest.

Employee Benefits

Provision is made for the liability for employee entitlements arising from services rendered by employees to 30 June 2023. Employee benefits have been measured at the amounts expected to be paid when the liability is settled, plus related costs.

Provisions

Provisions are recognised when the entity has a legal or constructive obligation resulting from past events, for which it is probable that there will be an outflow of economic benefits and that outflow can be reliably measured. Provisions are measured using the best estimate available of the amounts required to settle the obligation at the end of the reporting period.

Cash and Cash Equivalents

Cash and cash equivalents include cash on hand, deposits held on call with banks, other short-term highly liquid investments with original maturities of three months or less, and bank overdrafts.

Revenue Recognition

Revenue from the sale of goods is recognised upon the delivery of goods to customers.

Revenue from the rendering of services is recognised upon the delivery of the services to customers.

Revenue from commissions is recognised upon delivery of services to customers.

Revenue from interest is recognised using the effective interest rate method.

Revenue from dividends is recognised when the entity has a right to receive the dividend.

All revenue is stated net of the amount of goods and services tax (GST).

Goods and Services Tax

Transactions are recognised net of GST, except where the amount of GST incurred is not recoverable from the Australian Taxation Office (ATO). Receivables and payables are stated inclusive of the amount of GST receivable or payable. The net amount of GST recoverable from, or payable to, the ATO is included with other receivables or payables in the balance sheet.

Leases

Finance leases are leases of fixed assets where substantially all of the risks and benefits incidental to the ownership of the asset are transferred to the entity, but the legal ownership is not transferred to the entity.

Finance leases are capitalised by recording an asset and a corresponding liability at the lower of the amounts equal to the fair value of the leased asset, or the minimum lease payments measured at present value including any residual values.

Leased assets are depreciated on a straight-line basis over the shorter of their estimated useful lives or the lease term.

Operating lease payments are charged to the income statement on a straight-line basis over the term of the lease

Lease incentives are deferred and amortised over the period of the lease.

Profits and losses on sale and leaseback transactions are recognised in the reporting period in which they occur.

Grants

Grant revenue is recognised in the income statement when the entity receives the grant, when it is probable that the entity will receive the economic benefits of the grant and the amount can be reliably measured.

If the grant has conditions attached which must be satisfied before the entity is eligible to receive the grant, the recognition of the revenue will be deferred until those conditions are satisfied.

Where the entity incurs an obligation to deliver economic value back to the grant contributor, the transaction is considered a reciprocal transaction and the revenue is recognised as a liability in the balance sheet until the required service has been completed, otherwise the income is recognised on receipt.

Neighbourhood Watch Australasia Limited receives non-reciprocal contributions of assets from the government and other parties for a nominal or zero value. These assets are recognised at their fair value on the date of acquisition in the balance sheet, with an equivalent amount of income recognised in the income statement. Donations and bequests are recognised as revenue when received.

Government Grants

Government grants received are recognised as revenue on a basis to match the recognition of revenue with costs incurred in the project. The design, development and trials extend over a two year period and revenue from the government grant has been recognised on a straight line basis over that period.

As the peak body for Neighbourhood Watch (NHW) groups, **Neighbourhood Watch Australasia** (NHWA) supports NHW groups to apply for and access vital grant funding for initiatives and projects to benefit their local communities. Assistance to access grant funding is facilitated through the provision of auspicing and administrative support by NHWA for NHW groups who do not have an Australian Business Number (ABN), a prerequisite for eligibility for receipt of grant funds.

NHWA is committed to ensuring that NHW groups are not disadvantaged due to being ineligible or unable to apply for or access funding for the purpose of making their communities safer, more resilient, welcoming, and well-resourced.

During the 2022-2023 financial year, NHWA assisted 29 NHW groups in sourcing over \$37,500 in grant funding for local community events, initiatives, and resources.



Summary of NHWA auspiced grants for NHW groups during 2022-2023:

- 1. NHW Australia 26 NHW Groups in QLD, TAS and WA for a combined total of: \$28,600
- 2. NHW Riverview, QLD: \$5,500


